Players suspended by any of the above ranking organizations cannot compete in any of these events. NDFC Playing Attire Rule 19.1 will be enforced for the semi-finals and finals of both singles events. The NDFC Headgear Rule 19.2 is in effect for the entire tournament, with the exception of those providing medical evidence to the Tournament Organizers.
