4. Proof of recognition as the official governing body for Darts (if applicable).
5. Proof of recognition by the National Olympic Committee (if applicable).
6. Proof of funding from your government or National Sports Council (if applicable).

**In addition an application fee of USD 200.00 must be paid into the WDF bank account (see details below) before this application can be processed.**

Membership must be achieved in the same calendar year in which the application fee was paid. Failing this, a new application and application fee must be submitted.
